3. Selection of the candidate(s) will be based on the performance in Interview.
4. **In case of large number of eligible candidates after scrutiny of applications and it is not feasible to call all the candidates for interview, the appointing authority may adopt suitable higher criteria for short listing the candidates who will be called for interview.**

4. Submission of incorrect or false information during the process of interview/or Personal discussion shall disqualify the candidature at any stage.
